Resolution No.06 :

A Detailed discussion was held with respect to members of Yavatmal Zilha Akhil Kunbi Samaj, Yavatmal. The subject to allotment of land measuring 8650 sq meters at Survey Bhumapan No. 50, Nagapur Tal. Umarkhed Dist. Yavatmal for school building of Modern Public School, Nagapur Tal. Umarkhed Dist. Yavatmal.

As per discussion in the meeting the executive committee members unanimously observed that as per CBSE affiliation bye-laws it is absolutely necessary to have a separate land for Modern Public School, Nagapur Tal. Umarkhed Dist. Yavatmal.

In the meeting, all members further unanimously resolved that Yavatmal Zilha Akhil Kunbi Samaj, Yavatmal at Survey Bhumapan No. 50 Comprising of land measuring 121400 Sq.Mtrs (12 Hecture 14 R) land out of which 8650 Sq meters (2.13 Acres) is allotted for Modern Public School, Nagapur Tq. Umarkhed Dist. Yavatmal. The same can be used for the permanently.
