SI. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 23 only. School shall not increase the number of sections and any further increase in sections shall be strictly subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law subject to availability of class rooms of greater than 500 sq ft dimension.
2	The composite Science Lab entrance is three steps above which is not accessible by the wheelchair bound students. School should remove the steps and make necessary arrangements to make the lab accessible by the wheelchair bound student/staff. Further, the work stations are without permanent fixtures and the lab need to be upgraded as per the the circular no 11/2022 (SoP for labs, library and sports) and upload the compliance on SARAS portal within 03 months with YouTube video link.
3	The CwSN toilets at the first and second floors are not properly equipped with recommended infrastructure and facilities as per the mandatory provisions of the RPwD Act, 2016 and the Board guidelines vide circular no. 05/2023. The CwSN toilets are having support bars only on the one side of the commodes. The toilets should have required infrastructure to make proper use of the same by the CwSN. School should upgrade the toilets as per the circular no 05/2023 (

	(https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf) and upload the compliance on SARAS portal within 03 months.
4	The school is directed to upgrade the Indoor and Outdoor sports facilities and infrastructure in compliance of Board guideline vide SoP and circular no 11/2022. For outdoor games, the school has arranged for Volleyball, tennis and basketball on loose soil and the marking on the playground/courts are temporarily made with lime. The ground should be with solid courts with permanent marking. The indoor sports facilities are insufficient with only one TT and two chess boards. The school is directed to follow the circular no 11/2022 and upgrade the sports facilities as per recommended infrastructure and upload the compliance on SARAS portal within 03 months.
5	School shall ensure the mandatory training of its teachers from the CoE, CBSE Pune within three months and shall upload the complaince on saras portal.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/-every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
